**Summary of the main activities
in relation to these objects**

This last year we spread our work remotely across a number of areas:

- i) Providing facilitation of co-design hack events under our 'coding for public good' space. We ran four events this year.
- ii) Hosting the first Scottish Open Data Unconference to provide space for discussions around the use, opportunities and challenges of open data in Scotland.
- iii) Organising and delivering monthly meetups for Python developers, and for data scientists in order to share ideas, and help each other learn more about these two areas.
- iv) Running bi-monthly Young Coders learning sessions from 14 Sept 2019 to 04 March 2020. These attracted 114 young people to 10 sessions with a total of 24 volunteers.
- v) Running Aberdeen Data Meet-ups which between November 2019 and March 2020 saw 261 attendees come to 5 events at which we had 12 speakers on a variety of data related topics.
- vi) We are also working with others as part of Air Aberdeen to deliver an air quality monitoring system for the city.

APPENDIX 1

Achievements and performance

Summary of the main achievements of the charity during the financial period

Our first event of the reporting year was the [Scottish Open Data Unconference](#) on 5-6 November 2022. We saw 31 open space sessions with most attendees there in person this time. A small number also took part online. There were a total of 37 people taking part in the event.

We ran three **Hack Weekends** over the reporting year:

- [Code The City 28 - Connections](#) on 18-19 March 2023 saw 19 participants on day one, and 15 on day two, working on seven projects ranging from a tool to see who participated in which projects in the past, one updating a project from CTC 1 in 2014, and a WikiData Editathon focusing on updating information about the University of Aberdeen that added six new articles, plus 668 other articles were edited.
- [Code the City 29 - Health](#) on 17-18 June 2023 had 33 people on the Saturday, and 16 on the Sunday, working on four projects ranging from open prescribing data for Scotland to health data, and the food hygiene data pipeline.
- [Code the City 30 - Union Street and the City Centre](#) on 23-24 September 2023 saw us working with Our Union Street and 37 people on Saturday, and 20 on Sunday, working on 5 projects to make the city centre more useful to the community.

Scottish Open Data Unconference

In 2023 we hosted the next [Scottish Open Data Unconference](#) 2/3 October 2023 which meant two of these within the reporting year. This one had increased numbers, with 33 attendees on the Saturday and 24 on the Sunday. Saturday saw nine parallel sessions, while Sunday there were ten sessions.

Monthly meetups

Having restarted the monthly **Aberdeen Data Meetup** in October 2022, attendance continued to be very good with 243 attendees over the reporting period.

Similarly, we continue to run the monthly **Aberdeen Python User Group** meetings. These attracted 205 attendees for the reporting period. Both events have seen attendance both in person and online, although most people now attend in person.

Other optional information

2022-2023 was a mixed year for Code the City. While we have been able to cover our costs thanks to previous contributions, attendance at our events has been roughly the same as the previous year - or marginally less. This shows that the impact of the pandemic continues to be an issue. Our assessment of the situation is that in previous years we would see computing science and data science students join our events as new undergraduates and that cohort would stay with us, in the main, throughout their academic journey. During the pandemic, with events online, we didn't pick up the new potential attendees and we've not entirely recovered from that.
