Achievements and performance

Summary of the main achievements of the charity during the financial period	Our first event of the reporting year was the Scottish Open Data Unconference on 18-19 November 2023. We saw 31 open space sessions with most attendees there in person this time. A small number also took part online. There were a total of 63 people taking part in the event. We ran two Hack Weekends over the reporting year: <u>Code The City 31 - Democracy</u> on 16-17 March 2024 saw 21 participants on day one, and 17 on day two, working on four projects ranging from a tool to make it easier for parents to find unbranded school uniforms, and others providing metrics on city councillors. <u>Code the City 32 – Community Safety</u> on 21-22 September 2024 had 17 people on the Saturday, and 15 on the Sunday, working on three projects ranging from making it easier to book a taxi from the airport, to using AI tools to spot swimmers in distress on the beach.

Monthly meetups

The Aberdeen Data Meetup ran most months over the reporting period with mixed levels of attendance.

Similarly, the Aberdeen Python User Group meetings continued most months.

We had some issues with attendance in the summer months, which is something we'll consider pausing in the future. Informal discussions with other groups in the city suggest that attendance is down in general for meetups and similar events.
